GENERAL INFORMATION:

Safer® Brand Garden Dust, in its easy-to-use shaker canister, is a specially formulated dust to provide best results when caterpillars and worms are newly hatched. The active ingredient, Bacillus thuringiensis is a naturally occurring component of the environment. Safer® Brand Garden Dust is a highly selective insecticide for use against listed caterpillar pests. Honey bees foraging in treated areas are not harmed when Safer® Brand Garden Dust is used according to directions.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Application Rates: Apply Safer® Brand Garden Dust when pests are first noticed and repeat every 7 days to 10 days or as necessary. Caterpillar egg hatch can occur over an extended time period. Monitor treated areas for the presence of newly hatched pests and retreat if necessary. Thorough leaf coverage is necessary for effective control. After ingesting a treated portion of the leaf, caterpillars stop feeding within a few hours. Death occurs in a few days.

Apply to foliage of listed crops at a rate of 2 to 3 ounces per 50 feet of row plantings.
