Shake Before Using.

Hold sprayer 12 to 18 inches from surface and spray to achieve thorough coverage. Apply when insects or their damage first appears. Spray to thoroughly moisten all plant surfaces where insects are feeding or resting. Repeat treatment every 7 to 10 days when insects are present or as needed to prevent damage. Use with caution on new, tender foliage. Do not use this product in or around electrical equipment due to the possibility of shock hazard.

Use on Houseplants: To kill Aphids, Spider mites, Red mites, Mealybugs, Thrips, Scales, Caterpillars and Whiteflies. Apply when insects or their damage first appears. Spray to thoroughly moisten all plant surfaces where insects are feeding or resting. Repeat treatment every 7 to 10 days when insects are present as needed to prevent damage. **CAUTION:** Do not use on Crown of Thorns, Jade plant or delicate Ferns. Test on Begonias, Fuchsias and Impatiens for varietal sensitivity.

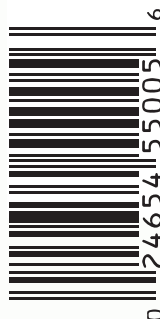
