**GENERAL INFORMATION:**

Whole Control can be used effectively to repel moles from lawns, gardens, flower beds, around playgrounds, golf courses, and other recreational turf areas. This product is not destroyed by rain and will remain effective for a minimum of 1 month when applied as directed.

**DIRECTIONS FOR USE:**

Apply Whole Control when the signs of moles digging, tunneling, and borrowing, first appear. This product may be applied to either wet or dry areas and will cover up to a 5,000 sq. ft. area when applied as directed. Depending on soil type, it may take up to a week for the product to reach maximum effectiveness.

**Initial Application:** Ensure sprayer knob is turned to "off" position. Attach garden hose tightly to self-dispensing container. Turn water supply on to full pressure. Turn sprayer knob to "on" position and spray Whole Control evenly over mole infested area at a rate of one quart of product per 5,000 sq. ft. (e.g. a 50 ft. by 100 ft. square). After Whole Control is applied, sufficiently water in the application with a garden hose or sprinkler to soak Whole Control into the soil.

**Follow Up Applications:** Apply Whole Control immediately after the presence of moles is detected or in early spring, mid-summer, or early fall if there are moles nearby but not on your property.

**STORAGE & DISPOSAL:**

**STORAGE:** Store only in original container, in a cool, dry, and well-ventilated location inaccessible to children and pets.

**DISPOSAL: If Empty:** Do not reuse this container. Place in trash or offer for recycling if available.

**If Partly Filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

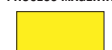
